The Sacrament of Marriage

Marriage is a Mystery of the Orthodox Church through which the union of man and woman is sanctified by God. The Orthodox Marriage ceremony, the most ancient of Christian wedding rites, is steeped in ritual and symbolism, reflecting the theology of the Church.

Communication

Often workloads, shifts, career demands, the needs of children, social and extended family activities leave very little room for meaningful communication. However regardless of all the activities and pressures of married life, the fact remains: communication is to a relationship what breathing is to living.

Legal Aspects

The law affects married couples in many ways, marriage being a legal commitment by two people to each other. We need to understand the importance of communication between couples to air and solve issues before they become irreconcilable and disastrous legal disputes. Areas in which couples may come into contact with the Law include: renting and purchasing a home, estate matters and matters relating to Family Law.

Financial Matters

Money may be able to buy a little temporary joy but it cannot buy lasting happiness. Satisfaction in terms of wealth is not only achieved by getting more but also by needing less in many instances. Managing our financial affairs affects many aspects of married life.

Marriage as a Journey

A journey is an act of travelling from one place to another: marriage is a road which starts out from the earth and ends in Heaven. The bride and bridegroom give their hands to one another, and the priest, representing Christ, takes hold of them both and leads them round the table dancing and singing. Marriage is a movement, a progression, a journey which will end in heaven, in eternity.
